Dear Colleagues,

"Career Protection" is having a professional association with the resources to protect the practice of social work. Why is malpractice insurance not enough? Because your malpractice insurer will not do the following - but NASW at the national level and through the Louisiana Chapter will:

- Provide highly discounted quality Continuing Education programs that are presented at regional locations and an outstanding Annual Conference.
- Provide consultation on ethical, practice, and career issues.
- Deliver critical, up-to-date information on laws and regulations that affect your practice.
- Continue to be a vigilant voice for Social Work practice and the profession at the Louisiana State Capitol and in Washington, DC.

NASW and ASWB Standards for Technology and Social Work Practice

The NASW, ASWB, CSWE, & CSWA Standards for Technology in Social Work Practice is the result of a collaboration between NASW, Association of Social Work Boards, Council on Social Work Education, and Clinical Social Work Association, which updated the previous technology standards, developed to create a uniform document for the profession. Technology has changed social work practice, offering new ways to perform services and obtain information. It is defined as any electronically mediated activity used in the conduct of competent and ethical delivery of social work services.

How Can I Help During a Disaster?

Whether it is a hurricane, flood, explosion, tornado, or pandemic flu, one cannot predict when an emergency will strike Louisiana. Yet, one knows that a multitude of volunteers - medical and non-medical - will be needed to help victims and provide for relief efforts. You can play a vital role in Louisiana's disaster response efforts!

Consider Becoming Part of the Louisiana Volunteers in Action (LAVA)

- Louisiana Volunteers in Action (LAVA) is Louisiana's approach to the federally mandated Emergency Systems for Advanced Registration of Volunteer Health Professionals (ESAR-VHP) Program. Created in 2007, this real-time, online state registry of medical and non-medical volunteers can systematically verify credentials before an emergency, thus ensuring that Louisiana has a competent, ready-to-deploy volunteer workforce.
- Upon joining LAVA, a volunteer's identity, qualifications, and experience will be verified. A volunteer's information is kept in a secure, statewide database which is only be shared with emergency management professionals. This information is used to coordinate volunteer efforts with a special emphasis on advanced credential verification and deployment based on skill set.

During a disaster, there is a need for social work services. We know social workers want to help. You may not know of a way to connect to match your skills with the identified needs. The LAVA network managed by the Office of Public Health, Department of Health knows all too well has identified that there are more behavioral health needs in times of disasters than the current system can provide. The following highlights where the services of social workers would be of great benefit:

- a. Shelters providing psychological first aid/skills for psychological recovery, care management/ connection to resources
- b. Bus Triage/Pick UP points providing psychological first aid/skills for psychological recovery, care management/connection to resources
- c. Stress Management/Postvention for disaster responders

Social Work Advocacy

Recently, we received a question in the Chapter office inquiring about advocacy. More specifically, the member asked, "What is NASW doing about the imminent threat to Medicaid and TrumpCare. We are going backwards in this "great" country?"

Social worker's knowledge base requires cultural competence, that is, an understanding of power, privilege, and oppression. Social work practice skills afford professionals the opportunity to intervene with clients, community systems, and society at large and to advance human rights, racial and economic equality, and social fairness. Social justice is the beacon of the social work profession, and association members are bound to protect the rights and dignity of all people and work with populations who see equality and justice.

The NASW has taken steps to inform the membership in a few critical areas at the national level. Many members have signed up to receive action alerts from the National office about federal initiatives. Shortly after the new administration took office, the staff in the National office developed a Transition Document to the Trump Administration. It was entitled, "Advancing the American Agenda: How The Social Work Profession Will Help". 2017 Louisiana Legislative Session Summary

In the following pages you will find a listing of all the bills and resolutions NASW-LA supported, opposed, monitored, etc., during the 2017 Regular Session of the Louisiana Legislature that made it through the process and were eventually enrolled. There were 618 House bills pre-filled and 236 Senate bills pre-filled; the House ended up filing 692 bills and the Senate ended up filing 257 bills, In addition, there were 121 House Concurrent Resolutions and 246 House Resolutions; 125 Senate Concurrent Resolutions and 225 Senate Resolutions. In essence, a very busy "fiscal" session, but obviously not enough time to pass a state operating budget or a capital overlay budget. The legislature also failed to deal with the pending fiscal cliff that looms ahead in fiscal year 2018-19. So, they had to return for yet another special session to get the budget issues done.
